The following candidates are hereby advised to report at below mentioned Regional Office for completion of Pre-Recruitment Medical Examination, verification of testimonials/certificates and other pre-recruitment formalities. We would advise the candidates to strictly adhere to the following instructions for completing Pre-Recruitment formalities.

- The provisionally selected candidates are advised to approach the Regional Office against which their names appear in the enclosed list for Medical Examination.
- The candidates should appear before the Medical Board as advised by our Regional Office concerned from **23.05.2016 to 25.05.2016**. In case, a candidate does not report for Medical Examination by **25.05.2016**, it will be construed that the candidate is not willing to join the Company.
- The Medical Examination for the first time will be done free of cost. If a candidate incurs any expenditure towards it, the same will be reimbursed by the Company against submission of bills.
- If the candidate is required to undergo Medical Examination again due to unsatisfactory report of the first Medical Examination, the charges, if any, will be borne by the candidate only.
- The travel expense, if any, in connection with the above, either for the Medical Examination for the first time or for subsequent Medical Examination, will be borne entirely by the candidate and no reimbursement will be made for the same.
- In case you are in employment, you will have to submit a clear Relieving/Discharge Letter from your employer in original on the day of reporting for joining the Company. Please note that under no circumstances, you will be allowed to join the Company where the relieving/Discharge Letter is not produced. **This requirement will come after issuance of Appointment Letter if any.**
- Candidates will have to bring original testimonials along with attested photocopies and four recent passport size photographs at the time of reporting for Pre-Recruitment Medical Examination. Original Caste Certificate along with attested photocopies is also to be brought in case of SC/ST/OBC candidates.
- The persons with Disability will have to produce Disability Certificates, issued by the Appropriate Authorities, at the time of reporting for Pre-Recruitment Medical Examination.
- Ex-servicemen are required to submit appropriate certificates viz. copy of Ex-servicemen service book, original release order etc at the time of reporting for Pre-Recruitment Medical Examination. Original and copies of the same shall also be produced for verification.
- **A call letter to each provisionally selected candidate is being issued for completing the Pre-Recruitment formalities/Medical Examination at their given e-mail id. Candidates are advised to check their e-mail account for the same.** Candidates are advised to paste latest photographs on the letter and submit the letter at our Regional Office at the time of Medical Examination.
- Candidates are advised to bring **photo identity card** at the time of Medical Examination.
- **The advices for reporting to the Regional Office is only for facilitating Medical Examination and must not be taken as an indication of appointment or final posting.**

Kindly note, that mere appearance of names in the waiting list does not entail any candidate for appointment in the Company. The issuance of Provisional Appointment is subject to satisfactory reports of Medical Examination, Caste Certificates, testimonials and any other document(s) as may be required. In case, it is found, at any stage even after appointment in the Company, that the candidate does not fulfill any of the criteria and/or the candidate has furnished any incorrect/incomplete information or has suppressed any material fact(s), his/her candidature will be cancelled. The decision of the Company in this regard shall be final and no correspondence will be entertained with the candidate.
