**RECRUITMENT SELECTION NOTIFICATION**

1. It is hereby notified that the Recruitment process (Preliminary, Main (Written) and Interview (Oral Test)) for selecting candidates, to 111 posts in Group-I Services, in the State of Andhra Pradesh, pursuant to the Notification bearing No. 28/2022 dated 30.09.2022 is completed except for one (01) post reserved for Sports Quota. The candidates whose register numbers are given below have been provisionally selected for appointments to the posts mentioned below vide Commission's Notification No. 28/2022 dated 30.09.2022 (G.R/L.R) subject to the following conditions.
  - i. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate having regard to his / her character and antecedents are suitable in all respects for appointment to the service,
  - ii. That the candidates are found physically fit for the post.
  - iii. That the candidates should produce such other original certificates as may be required to the appointing authority in accordance with the Rules.
2. If it comes to the notice of the Commission later that any candidate furnished false information or the selection is not in order, due to any act of omission or commission of any candidate, then his/her provisional selection is liable to be cancelled at any stage and he/she will forfeit all consequential benefits including that of selection. Besides, the Commission reserves the right to take any action as it deems fit in the circumstances of the case, in terms of the various enabling provisions as notified in Notification No.28/2022, dated: 30.09.2022.
3. The selection of BC-E candidates is subject to the outcome of Civil Appeal No.(a) 2628-2637 of 2010 in SLP.No.7388-97 of 2010 dated: 25.03.2010 and orders from the Government and other cases pending if any.

4. The selections of 19 carried forward (CF) vacancies shown in Annexure-I of Notification No.28/2022 to the posts notified under PC Nos. 01, 02, 06, 08, 11,15 (in Zone-IV- OC (G)L) & 16 are subject to the outcome of W.P.No's 15750, 15701, 15758, 15745, 15844, 15765, 15753, 15806, 15757, 16646, 21894, and 3079 of 2022 Batch cases, and W.P.No. 28011 of 2022 on the file of the Hon'ble High Court of Andhra Pradesh at Amaravathi and other cases pending, if any.
5. The selectees are informed that their selection would be subject to the outcome of the above referred Writ Petitions.
6. Although every care has been taken in preparing the Result, possibility of inadvertent /technical error cannot be ruled out. The Commission reserves the right to rectify the same later on.
